SSAIB certification

Certification against this SSAIB scheme will demonstrate compliance with the ACPO and ACPO (Scotland) policies on Police response to security systems and the Chief Fire Officers Association's (CFOA) Policy on remote monitored fire alarm systems (RMFA). It will enable the certificated stations to monitor intruder and fire alarm systems and route activations to fire service and police control room to initiate a response. The scheme is also recognised by insurers and SSAIB is accredited to operate it by UKAS. The scheme requires that the certificated company operates a management system which satisfies the SSAIB scheme criteria. However, your management system is not required to be certificated as an ISO 9001 Quality Management System and this is not a mandatory requirement of these schemes.

Many providers operate efficient and effective businesses with quality management systems not formally accredited to ISO 9000 but which are perfectly compatible with their business need.

However, SSAIB is able to provide ISO 9001: 2000 certification if a more formal approach is preferred.

SSAIB has wide UKAS (United Kingdom Accreditation Service) Accreditation, which means that our approach is subject to independent scrutiny and validation against international standards.

The market and your business

Monitoring centres, in particular ARCs, are performing a central and critical role in both the fire and intruder alarm sectors. Activations from monitored fire and intruder systems must be routed through an ARC for verification prior to being passed to the relevant authority for a Police or Fire Service response; the aim of this approach being to minimise the number of false alarms handled by the emergency services.

BS 8418 similarly aims to minimise false alarms by using detectors to trigger CCTV activation, with images being transmitted to remote stations. This scheme calls upon a wide range of standards and requires the facility to 'audio challenge' a potential intruder. A URN for the installation is required to initiate a Police response.

Third Party Certification will be required for all monitoring activities that are intended to involve an emergency service response. SSAIB certification will demonstrate that you operate a well managed, ethical business and that you are technically informed and competent; all of which provide confidence in you as a provider of security services.

Criteria for Certification

Providers must demonstrate that they can:

- Operate and maintain monitoring equipment to relevant British or European Standards.
- Have appropriate management systems and procedures in place.
- Have relevant personnel security screened
- Meet certain financial criteria and are financially stable.
- Have appropriate insurance cover.
- Have suitable premises, where confidentiality can be observed with adequate safeguards for the security of sensitive information. A category 2 ARC must be able to withstand determined physical attack.
- Have trained staff and implement training procedures
- Have sufficient systems installed and/or monitored to allow a trading history to be demonstrated.

The ability to be able to claim and demonstrate compliance with all of the above is a valuable marketing tool for your business.
